Sehubungan dengan surat Director Nuffic Southeast Asia perihal *Dutch Training and Exposure Programme (DUTEP) 2025*, kami sampaikan hal-hal sebagai berikut:

1. *Dutch Training and Exposure Programme (DUTEP) 2025* merupakan salah satu program pengembangan kompetensi yang diselenggarakan oleh *Dutch Water Sector* dan dikoordinasikan oleh *Nuffic Asia Tenggara*, dengan topik:

3. Telah dikirimkan 2 (dua) orang peserta pada program DUTEP tahun 2024 yang dilaksanakan pada September-Oktober 2024 dengan pembiayaan *cost sharing* dari Direktorat Jenderal SDA,
4. Apabila program akan dilaksanakan mohon kiranya dapat dilakukan evaluasi terhadap kebermanfaatan program dan melakukan seleksi ketat terhadap peserta yang diusulkan dengan mempertimbangkan pegawai berprestasi dan sesuai dengan bidang tugas yang dijalankan;
5. Sehubungan dengan hal tersebut, bersama ini kami menawarkan kembali program dimaksud sekiranya dapat dialokasikan anggaran pada Direktorat Jenderal SDA untuk kebutuhan *cost sharing* penyelenggaraan pelatihan tersebut;
6. Sebagai informasi, batas akhir pengiriman calon peserta kepada Nuffic Asia Tenggara pada tanggal 20 Mei 2025.

Dear Ibu Canka,

Congratulations on your appointment as Head of the Human Resources Development Agency at the Ministry of Public Works of the Republic of Indonesia.

Following the Government-to-Government meeting between the Dutch Ministry of Infrastructure and Water Management and the Indonesian Ministry of Public Works on November 12th, 2024, and on request of Secretary General Mohammad Zainal Fatah, we are pleased to reach out with the following proposal:

In reference to the MoU on Water between Indonesia and the Netherlands (2022–2027) and in light of our long-standing and successful collaboration in the water sector, we are excited to offer PU an exclusive opportunity for capacity building and knowledge exchange in water management through the **Dutch Training & Exposure Programme (DUTEP)**. This programme, led by the Dutch water sector and coordinated by Nuffic Southeast Asia, presents a unique opportunity for young government officials at PU to deepen their expertise in integrated urban water management by spending research-internship of 8 weeks at Dutch water companies in the Netherlands.

In 2024, two participants from PU successfully participated in DUTEP, and we are eager to continue this success in 2025. With this letter, we would like to inform you that the selection process for young government officials from PU to join the Dutch Training & Exposure Programme (DUTEP) will open in March 2025. Candidates will be offered a two-months placement in September-October 2025 at a Dutch host organisation. The host organisations and topics for 2025 are still being finalised; for now, please allow us to refer to the organisations and topics from 2024:
